Dues - GST

Dues quoted include GST applicable under the federal government's Goods and Services Tax law.

Dues - permanent full-time

- Dues are quoted on salaries payable as at 31 October 2012.
- Dues will be calculated at 0.72 of one per cent of a member's annual salary
- A **10 per cent discount** will be applied if dues are paid in full by 31 March 2013.

Dues - permanent part-time

- Permanent part-time teachers' dues will be calculated at 0.72 of one per cent of the annual salary for that member's classification, multiplied by the proportion of the total time employed in that year.
- A **10 per cent discount** will be applied if dues are paid in full by 31 March 2013.

Dues - tax deduction

Paying by direct debit

- The Queensland Teachers' Union offers payment by direct debit through a financial institution of the member's choice.
- Please note that direct debit can be one instalment or in 10 equal instalments on set dates throughout the year.

If the direct debit request is received during the year (after 15 February) and the member wishes to pay via a number of instalments, then the amount payable will be divided equally between the instalment dates remaining for the year.
