### NOTES

#### Dues - GST

Dues quoted include GST applicable under the federal government's Goods and Services Tax law.

#### Dues - permanent full-time / part time

- Dues are quoted on salaries payable as at 31 October 2018.
- Permanent full-time teachers' dues will be calculated at 0.72 of one per cent (plus GST) of a member's annual salary.
- Permanent part-time teachers' dues will be calculated at 0.72 of one per cent (plus GST) of the annual salary for that member's classification, multiplied by the proportion of the total time employed in that year.
- A 10 per cent discount will be applied if dues are paid in full by 31 March 2019.

#### Dues - tax deduction

Union dues are fully tax deductible.

#### Joining after 31 March 2019

#### Paying by direct debit

- The Queensland Teachers' Union offers payment by direct debit through a financial institution of the member's choice.
- Please note that direct debit can be one instalment or in 10 equal instalments on set dates throughout the year.

*If the direct debit request is received during the year (after 8 February) and the member wishes to pay via a number of instalments, then the amount payable will be divided equally between the instalment dates remaining for the year.*
