Election Notice

The Queensland Industrial Registrar has issued Decisions, pursuant to the *Industrial Relations Act 2016*, that the Electoral Commission of Queensland conduct an election for positions of office within the Queensland Teachers Union of Employees.

Candidate Notes

Candidates for election must be financial members of the Union at the close of nominations. All nominations must be in writing and signed by the nominee. Nomination forms must also be signed by at least two (2) financial members of the Union, provided that:

Nominations for **State Conference Delegate of a Branch, Branch Delegate to an Area Council and State Council Representative of a Branch** must be a member of the respective branch and must be signed by at least two (2) financial members of the relevant branch.

State Conference Delegate of TAFE Division must be a member of the respective TAFE Division and signed by at least (2) two financial members of the relevant TAFE Branch.

Conference Delegate of Aboriginal and/or Torres Strait Islander descent must have identified themselves as being of Aboriginal and/or Torres Strait Islander descent in accordance with procedures of the Union and be signed by at least two (2) financial members of the Union.

Area Council Officer positions must be Branch Delegates to the relevant Area Council or a duly nominated candidate for election as a Branch Delegate to the relevant Area Council and signed by at least two (2) Branch Delegates to the relevant Area Council.

Candidates who wish to withdraw their nomination may do so not more than five (5) clear days after the close of nominations. Prospective candidates and their nominators should verify their financial status and other qualifications required by the Union (refer to Union Rules 6.4 & 6.5).

Nominations close at midday on Tuesday, 27 November 2018

Nominations open on **Friday, 2 November 2018**, and must be in writing, comply with the registered rules of the Union and be received by the Electoral Commission of Queensland (the Commission) no later than **midday on Tuesday, 27 November 2018**.

A nomination form for this election is printed with this Journal. Forms are also available from the Union and the Commission's website; www.ecq.qld.gov.au.

Nominations may be received by hand delivery, post, fax or email and must include the signatures of the nominees and nominators. Please ensure that your nomination can be clearly read.

Ballots

Should a ballot be necessary to elect the successful candidates for State Conference Delegate of a Branch, State Conference Delegate of TAFE Division or Conference Delegate of Aboriginal and/or Torres Strait Islander descent, Branch Delegate to an Area Council or State Council Representative of a Branch the Commission will conduct a secret postal ballot of financial members of the Union. These ballots, if required, will **open on Friday, 25 January 2019** and **close at midday on Monday, 18 February 2019**.

Should a ballot be necessary to elect the successful candidate for the Area Council Officer positions the Commission will conduct a secret ballot of Branch Delegates at the Council meeting to be held after nominations close.

To be eligible to vote in this election, members must be financial for 30 days before the opening of nominations. The voting system is Optional Preferential.
